### **Certification of Understanding**

In connection with the above Agreement, I hereby certify as follows:

1. I understand the Sungroper solar car is an experimental vehicle and that its performance and safety will be tested before, during and after the Wold Solar Challenge event (or any other event), and that there are limited certification standards for solar vehicles, drivers and instructors.
2. I understand that solar car driving is a potentially dangerous activity, and creates risks such as (among other things) the possibility that the solar car may have been poorly designed or constructed. That it might prove beyond the ability of a driver to handle in a safe manner, and that unsafe weather or other dangerous conditions may arise suddenly and unexpectedly.
3. I understand that the Sungroper solar car I will be driving or assisting has not been inspected or regulated to the normal standard of a commercial vehicle. I also understand that the drivers have only a relatively small amount of experience with driving solar cars.
4. Further, I understand that during the event and while getting to and returning from the event and during overnight stops, I may be exposed to unforeseen risks by virtue of the need to travel and camp in unfamiliar and undeveloped conditions.
